NOTICE TO ALL CONTRACTORS

You are hereby notified of the following changes, clarifications and/or modifications to the original Contract Documents, Project Manual, Drawings, Specifications and/or previous Addenda. This Addendum shall supersede the original Contract Documents and previous Addenda wherein it contradicts the same, and shall take precedence over anything to the contrary therein. All other conditions remain unchanged.

This Addendum forms a part of the Contract Documents and modifies the original Contract Documents dated *February 10, 2023, and Addendum #1, dated March 7, 2023.* Acknowledge receipt of this Addendum in space provided on the Bid Proposal Form. Failure to acknowledge may subject Bidder to disgualification.

A. DELETIONS, ADDITIONS, CHANGES, REVISIONS

Item:

- REVISE: Specification Section 00300 BID PROPOSAL FORM ADDENDUM #1.
 DISREGARD existing Section 00300 BID PROPOSAL FORM ADDENDUM #1, Subsection 1.H.
 Note: Subsection 1.H. relates to bid alternates which were removed in Addendum #1. This section can be disregarded.
- 2. REVISE: Specification Section 26 00 90 ELECTRICAL DEMOLITION. REVISE existing 26 00 90 ELECTRICAL DEMOLITION, subsection 3.02D to state: "All equipment, luminaires, devices, etc., which are removed shall become the property of the Contractor and shall be legally removed from the Project site."

Note: The College has confirmed that no electrical equipment needs to be salvaged or delivered for disposition. All electrical equipment and conduit can be demolished with the building.

3. REVISE: Note on Construction Drawing Sheet CS200.

REVISE the following note from sheet CS200: "Existing Drainline per Record. Contractor to locate and verify if in use. Ensure downstream infrastructure is protected/maintained if drainline is found/in use." To state "Contractor to cut and cap drainline"

Note: Verification of the drainline is not required. College has confirmed it is not in use.

- **4. CLARIFICATION:** All loose large furniture items are to be removed by the College prior to the start of construction. Contractor will only be required to remove permanent fixtures and equipment.
